



Product Limited Warranty

World Changing Technologies Pte Ltd Photocatalyst Coating Product

World Changing Technologies Pte Ltd (hereafter "WCT") warrants that WCT Photocatalyst Coating Product (hereafter "Product") is manufactured free from defect for a period of one (1) year from date of original shipping date in accordance with its product specifications.

If the Product fails to conform to the Product description, or proves to be subjected to any defects in materials under normal use within the one (1) year Limited Warranty period, WCT will provide sufficient Product to replace the defective Product.

1. Limited Warranty:

Subject to the terms and conditions of this warranty, WCT warrants that the Product will retain its photocatalytic properties during the warranty period. The warranty period extends for one (1) year from original shipping date.

2. Conditions of Warranty:

WCT liability hereunder shall be subject to the following terms and conditions:

- a. The claimant must provide proof of purchase.
- b. This warranty is not transferable;
- c. All warranties, conditions, liabilities and obligations other than those specified in this warranty are excluded;
- d. The Product must be applied strictly in accordance with the relevant WCT Technical Manual (includes Product Manual, Operator Manual or Partner Certified Application Manual) current at the time of application and must be applied using a WCT electrostatic sprayer as specified in that manual.
- e. Maintenance must be undertaken in accordance with the current WCT Technical Manual relevant to the Product performance and no liability and responsibility will be accepted whatsoever in relation to Products which have not been properly maintained.
- f. If WCT is reasonably satisfied a claim made under this warranty policy is valid, it will supply replacement Product.

3. Limitation of Warranty:

This warranty sets forth the entire agreement of WCT, regarding WCT liabilities and obligations with respect to the Product.

There are no promises, representations, warranties covenants, agreements, undertakings or guarantees with respect to the Product other than those expressly set forth herein; and, in furtherance of the foregoing, no oral or written advises, recommendations, affirmation of fact, description of goods, sample, model, plan or specification, whether or not the same relates to the production or any characteristic of the production, shall constitute, or be deemed to constitute, a warranty or other guarantee with respect to the Product.

This warranty is in lieu of all other express warranties. Except as to title, all other implied warranties, if any, relating to the Product shall not extend beyond the warranty period.

The limited warranty for the WCT Product shall not cover defects caused by modification, alternation, or repair of the WCT Product by anyone other than a certified Partner authorized by WCT.



Product Limited Warranty

The limited warranty for the WCT Product shall only apply when the product is applied with a WCT electrostatic sprayer by an authorized Partner certified by WCT.

4. Additional Exclusions:

This limited warranty does **NOT cover** damage or defects resulting from, or in any way attributable to:

- a. The improper storage of the Product beyond recommended condition;
- b. Installation and application of the Product by anyone other than an authorized Partner or Partner's technician certified by WCT;
- c. Poor surface preparation;
- d. A breakdown of the underlying surface including but not limited to previous paint film, stucco, textile, concrete, glass, dry wall, metal, or any other substrates in neglect;
- e. Tampering; including but not limited to diluting, or changing concentration by adding any solutions or solvents, including water;
- f. Insufficient lighting, air circulation, water moisture, or any other impediments that will prevent or degrade photocatalysis;
- g. Abuse;
- h. Acts of God including, but not limited to, hurricanes, cyclones, tornadoes, floods or other severe weather conditions or unusual climatic conditions.

THIS WARRANTY SPECIFICALLY EXCLUDES LABOR OR COST OF LABOR OR INCIDENTAL OR CONSEQUENTIAL DAMAGES ASSOCIATED WITH THE USE OF THIS PRODUCT.

5. Limitation of Damage:

Except as expressly set forth in this warranty, in no event shall WCT be responsible or held liable for special, collateral, indirect, incidental or consequential damages of any kind or nature including, but not limited to, loss of business or profits, or injury or damage to person or property.
